

# Cutting Edge Sports Training Camp Waiver

## Waiver and Release Agreement

I, the Releasor, being of lawful age, and legally on behalf of the Participant, in consideration of Participant being permitted to participate in the Releasee's related activities in 2010, WAIVE, RELEASE, and DISCHARGE the Releasee, its owners, officers, directors, employees, members, volunteers, agents, assigns, legal representatives and successors, lessors, landlords, and all business associates, affiliates and partners including but not limited to Ladera Ranch Maintenance Corporation (LARMAC) and Merit Property Management (Merit) and that are or may be involved in the presentation of the above noted activity and their owners, officers and employees and each of them, from all liability for or by reason of any damage, loss or injury to person and property, even injury resulting in the death of the Participant, which has been or may be sustained in consequence of the Participant's participation in the activity described above, and notwithstanding that such damage, loss or injury may have been caused solely or partly by the negligence of the Releasee.

I hereby acknowledge and agree that I have carefully read this Waiver and Release Agreement, that I fully understand same, and that I am freely and voluntarily executing same.

By signing this release I will be forever prevented from suing or otherwise claiming against the Releasee for any property loss or personal injury that Releasor or Participant may sustain while participating in or preparing for the above noted activity.

I have been given the opportunity and have been encouraged to seek independent legal advice prior to signing this Waiver and Release Agreement.

I understand that Participant would not be permitted to participate in the above noted activity unless I signed this Waiver and Release Agreement.

I understand that this Waive and Release Agreement is binding on me, my spouse, my heirs, my executors, administrators, personal representatives, Participant and assigns.

I acknowledge that Participant does do not have any physical limitations, medical ailments, physical or mental disability that would limit or prevent Participant from

participating in the above mentioned activity, and, if required, will obtain a medical examination and clearance.

This release contains the entire agreement between the parties to this release and the terms of this release are contractual and not a mere recital.

This Waiver and Release Agreement will be construed in accordance with and governed by the laws of the State of California, and it is acknowledged by the Releasor to be as broad and inclusive as permitted by the laws of this jurisdiction.

I HAVE READ AND UNDERSTAND THIS AGREEMENT, AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, PARTICIPANT, AND ASSIGNS MAY HAVE AGAINST THE RELEASEE(S).
